NO ALTERATIONS SHOULD BE MADE TO THESE SPECIFICATIONS.




## **THE CHILDREN'S ENVIRONMENTAL HEALTH COLLABORATIVE**

The Children's Environmental Health Collaborative is a UNICEF-led, managed and resourced initiative. It is not a legal identity and therefore is not a logo but an icon. The Global Collaborative platform connects with existing global alliances and partnerships on issues of climate, environment and health to drive action for children. It will unify efforts to continuously drive partnerships and public facing advocacy on children's environmental health.

The Collaborative will spotlight the major risks children face, and it will engage stakeholders to address these challenges. The Collaborative will host forums and a central hub for exchanging technical resources, experiences, and good practices.

Membership is open to governments and international organizations, including the private sector and civil society.



The icon with partner logos – reversal







# Icon exclusion zone

To ensure its integrity and visibility, the icon should be kept clear of interference from any other text, images or graphics. A minimum area of clear space has been defined around it. It must be surrounded on all sides by an adequate clear space – a space equal in size to the height of the ‘heart’ of the icon.

# Icon minimum size

To ensure proper detail and legibility, the icon should never be used in sizes smaller than shown. The minimum size of the icon is 35 mm in width. The stamp icon minimum size is 20mm in width and icon with partners minimum size is 50mm.

# Icon dos and don'ts

The following examples demonstrate correct and incorrect ways to use the icon.



Dos



Do only use the icon as supplied.



Do ensure that icon reversals follow the brand guidelines.



Do only display the icon on uncluttered backgrounds.



Don'ts



Don't change the proportions of any element.



Don't distort the icon.



Don't use colours that are not specified.



Don't box the icon.



Don't display the icon on a coloured background that makes it hard to read.



Don't display the icon on a busy background.
